

Narcan Nasal Spray Kits Distributed as Needed

PAS remains an authorized harm reduction agency with a CDPHE Standing Order. This permits PAS to maintain a supply of Narcan kits to be made available at exhibits and to program participants who indicate opioid use as a concern.

Peer Health Programs Created in Statute

- HB 22-1235 Veterinary Professionals Practice Act Sunset created the regulation of Veterinary Technicians

 facilitating access to the Veterinary Professionals Peer Health Assistance Program as of January 1, 2023
- SB 22-058 created a Peer Health Assistance Program for Dental Hygienists in July 2023


